Subject: Extension of the Phase-II Undergraduate Admission Schedule for Four-Year Undergraduate Programmes (FYUGP) and Five-Year Integrated Postgraduate Programmes (IPG) for the Academic Session 2026-27.

In view of numerous representations received from aspirants regarding extension of admissions to Undergraduate (UG) and Integrated Post-Graduate (IPG) programmes across Government Degree Colleges of J&K, it is hereby notified that the last date for filling up of vacant seats, including Open Merit and Supernumerary Seats, has been extended as per the schedule given below:

5.	Completion of admission formalities for all	Up to 19 September 2026, 05:00 PM

Important Instructions for In-person counselling regarding Programmes listed in Annexure 'A':

1. All colleges shall conduct the In-Person Counselling for vacant seats on 19-09-2026 from 11:00 AM onwards. Candidates shall be required to report at the designated counselling centres at 10.00 AM.
2. All candidates, or their parents/guardians or authorised representatives, as permitted under the admission rules, who have submitted their preferences for the said college need to be present at the time of the counselling session. No separate counselling schedules will be published by the colleges.
3. All choices submitted for admission during the previous in-person counselling round will be automatically erased. Candidates who wish to participate in the In-person counselling Round must submit fresh programme choices by 11:00 AM on 18 September 2026. Candidates who do not submit fresh choices will not be considered for Annexure 'A' programmes.
4. If a candidate who has already completed admission formalities in a college participates in a subsequent allocation round, by submitting fresh preferences and is allotted a seat against any of those preferences, his/her existing admission shall stand automatically cancelled upon such allotment. The previous admission cannot be reclaimed after a new seat is allotted.
